UPDATES

WATER POLICE UPDATE

The Water Police have now moved their vessels and air berths from their mooring point at Yarralumla West Jetty to Yarralumla East Jetty.

The upgrades to the East jetty are completed and the secure fence is now on the jetty. The Yarralumla West Jetty is now in the decommissioning phase for handback to the NCA. The removal of the old bowser and fence is all that remains. There is no AFP operational equipment left on the jetty.

The old fuel tank is being removed starting this week (week starting 31 August) and is expected to take 3 to 4 weeks.

The Water Police are still in the planning process for their new building at the Old Canberra Girls Grammar rowing shed. At this time, it is anticipated that the building upgrade will not be completed until December at the earliest, so they will continue with their current operating arrangements until then.

SCRIVENER DAM FLOOD OPERATIONS

During the August 2020 flood event, approximately 37,000 ML passed through the floodgates in a 72-hour period. This is more than the whole volume of the Lake!

DID YOU KNOW? 37,000 ML is the equivalent of 14,800 Olympic Swimming Pools.





We also removed over 45 tons of logs and debris from the lake. The equivalent of more than 7 adult African elephants.

SAFETY REMINDER AFTER FLOODS

Just a reminder that after heavy rainfall, particularly when the Dam floodgates are opened, there will probably be an increased number of logs and debris floating in the Lake.

Following an event, NCA contractors inspect for damage/logs/debris as soon as it is safe and practical to do so and clean up commences shortly after. However, this process can take 2+ weeks, or longer, as debris continues to flow into the Lake after the event.

Please be aware of these potential hazards, and of other Lake Users who may be navigating away from the traffic flow to avoid them.

A reminder that swimming is not recommended after rain events due to increased bacteria.

ACTON WEST DEVELOPMENT

The NCA is currently assessing the works approval application for West Basin boardwalk and land reclamation and has requested further information from the applicant.

PADDLE BOATS

Capital Paddle will not be moving to Aspen Island anymore. They will operate again in the warmer months from their location next to Regatta Point jetty.

LAKE WALLS RENEWAL PROGRAM

The first phase of stabilisation behind the walls of Lake Burley Griffin is nearing completion including resin injection behind 3.95km of stonewalls, posing a high risk.

Additional works delivered to improve public safety and aid in prolonging the life of the lake walls includes the repair of loose wall capping stones/pavers along the RG Menzies Walk, filling in sink holes landscape areas and the removal of two dead trees at risk of falling into the lake.



NGA FORESHORE UPGRADE

Works to widen the shared path that runs between the National Gallery of Australia Sculpture Garden and lake foreshore path have commenced. The works include improved access to the Sculpture Garden, new lighting, terraced seating walls and minor landscape and supporting works.

The completion is expected in mid-November.

CANBERRA AQUA PARK (CAP)

The NCA has received a Works Approval application from Canberra Aqua Park for the temporary installation of inflatable structures on Lake Burley Griffin and ancillary onshore structures, at Black Mountain Peninsula.

Following last year's trial, this application seeks approval to operate for the warmer months (November to February) for the next three years (to 2023).

The NCA welcomes community feedback on this application by close of business Friday 11 September 2020.

CANADIAN FLAGPOLE REFURB

This year, the NCA will be restoring the Canadian Flagpole on Regatta Point to allow for its safe and continued use.

The first stage is to get the pole down and stored in a safe spot to undertake further investigations.

DID YOU KNOW? In November 1955 a 40.2 metre single green spar of Douglas Fir, logged from a forest in British Columbia and weighing 7.1 tonnes, arrived in Sydney with its bark still attached.

After being submerged in Sydney Harbour for several days for quarantine reasons, it was transported by train to Canberra, straddled along the length of three railway trucks.

The pole was trimmed to 39 metres, debarked and shaped and handed over from Canada on 20 November 1957.



KINGS PARK PUBLIC CONSULTATION

The NCA is preparing to release the draft *King Park Improvement Strategy*.

Historically Kings Park (the Park) has been largely underdeveloped. With increasing use of the park we are concerned that safe and efficient use of the park is becoming more difficult. The NCA considers that there are ways to improve everyone's enjoyment and experience of the Park. We are looking at parking, vehicular, pedestrian, cyclist movements and signage.

The NCA will release a draft Strategy for community consultation within the next few weeks. The community will be encouraged to have their say on the proposed changes. A survey will also be conducted as part of the consultation so watch your emails for when this survey is live.

It is hoped that throughout this process:

'Kings Park evolves into a more user friendly precinct, with a focus on the evolution of better pedestrian and shared park users experiences, and an enabler for greater patronage in the Park with streamlined and safer parking and traffic management'.

Keep a look out for updates and the survey on the NCA's website www.nca.gov.au. It is anticipated this project will open for community consultation on Friday 4 September 2020.

In September, Canberra Anglers Association will continue their annual free public fly casting instruction on the lawns in front of Old Parliament House (opposite Questacon from 10-12, 13 & 20 Sept at Old Parliament House, before moving to Googong Dam 27 Sep). It is a long standing tradition, and supports the club fundraise, engaging with the public and promote fly fishing, continued in a COVID Safe manner in 2020.

In 2020 Canberra Anglers Association this year celebrates its 75th Anniversary. Its origins can be traced to an ad on 11 Oct 45 in the Canberra Times for like-minded anglers to meet at the Kingston Hotel, but is more historically documented in perpetual trophies like the annual Lyle Knowles trophy which began on the Cotter River in 1945, and has names like Bryan Pratt engraved on it. The club had a clubhouse on the shores of the river not far from where fly casting now occurs - in front of (old) Parliament House – removing it ahead of the Molonglo River becoming Scrivener Dam. CAA also supports other activities such as Casting For Recovery, in support of local breast cancer


