# Draft Amendment 63 – Molonglo and North Weston

The National Capital Authority proposes National Capital Plan **Draft Amendment 63 - Molonglo and North Weston** to enable urban development to occur within Molonglo and North Weston. The Draft Amendment is required to provide for the continuation of urban development in the Territory, while ensuring adequate protection of the National Capital Open Space System. New Broadacre Areas land use policy will also be created to recognise existing uses, and balance the loss of Broadacre land in North Weston.

Draft Amendment 63 of the National Capital Plan has been prepared in accordance with sections 15(1) and 23 of the Australian Capital Territory (Planning and Land Management) Act 1988 and is now available for public inspection and comment. Background information on the proposal is included with the Draft Amendment and is available on the Authority's website [www.nationalcapital.gov.au](http://www.nationalcapital.gov.au).
